Failure to make the envelope as instructed will result on a "NO BID" and will be mailed back to the sender. Rosebud Sioux Tribe will not accept e-mailed, faxed, or telephone bid(s).

The Rosebud Sioux Tribe has the right to reject any and/or all bid(s), waive informalities, or accept any bid(s) or a combination thereof in which it appears to serve the best interest of the Tribe. Indian preference in the selection process will be adhered to. Awarding of the bid(s) will be subject to the Rosebud Sioux Tribe Business Regulatory requirements.
