

**ROSEBUD SIOUX TRIBE  
RESOLUTION NO. 2022-03**

**WHEREAS,** the Rosebud Sioux Tribe is a federally recognized Indian Tribe organized pursuant to the Indian Reorganization Act of 1994 and all pertinent amendments thereof; and

**WHEREAS,** the Rosebud Sioux Tribe is governed by a Tribal Council made up of elected representatives who act in accordance with the powers granted by its Constitution and By-Laws; and

**WHEREAS,** the Rosebud Sioux Tribal Council is authorized to promulgate and enforce ordinances for the maintenance of law and order, and to safeguard the peace and morals, and general welfare of the Tribe, pursuant to the Rosebud Sioux Tribe Constitution and By-laws, Article 1, Sections 1 (k), and (m); and

**WHEREAS,** the Rosebud Sioux Tribe Health Administration has requested a quote from Buche's Foods; and

**WHEREAS,** the Buche's Foods quote returned with an order total of \$250,000.00; and

**WHEREAS,** the Buche's Foods purchase order amount is budgeted out of the Health Administration funding; and

**WHEREAS,** these supplies shall be used by Rosebud Sioux Tribal members to prevent and mitigate the spread of COVID 19 infection; now

**THEREFORE BE IT RESOLVED,** the Rosebud Sioux Tribal Council approves the purchase order for Buche's Foods in total of \$250,000.00 in cleaning supplies and disinfectant from R.F. Buches to be used for putting together and distributing cleaning kits to families, households, and the public to distribute to mitigate the spread of COVID 19 who are in isolation or quarantine.


**C E R T I F I C A T I O N**
