**Resolution No. 2021-295**

**WHEREAS,** the Rosebud Sioux Tribe is a federally recognized Indian Tribe organized pursuant to the Indian Reorganization Act of 1934 and all pertinent amendments thereof; and

**WHEREAS,** the Rosebud Sioux Tribe is governed by a Tribal Council made up of elected representatives who act in accordance with the powers granted to it by its Constitution and By-laws; and

**WHEREAS,** the Rosebud Sioux Tribe is acting under the authority pursuant to Article IV, Section 1 (f) of the Constitution and By-Laws; and

**WHEREAS,** the Rosebud Sioux Tribe has enacted Ordinance 80-03, as amended, to create the Rosebud Sioux Tribe's Judiciary Committee, to operate with participation from tribal membership and communities to develop and coordinate all aspects of law and order of the Rosebud Sioux Tribe; and

**WHEREAS,** The Rosebud Sioux Tribe Adult Corrections Facility has requested the Rosebud Sioux Tribal Council adopt a Policy and Procedure for the use of Electronic Control Device, or Tasers, and its authorized use and placement on an approved use of force continuum; and

**WHEREAS,** The RST Adult Corrections Facility has provided the RST Judiciary Committee with the extensive training procedure addressing the nature of the weapon, its capabilities, and the potential deployment effects; and


**THEREFORE BE IT RESOLVED,** That the Rosebud Sioux Tribal Council adopts and approves the Policy and Procedure for the use of Electronic Control Devices, or Tasers, Section 3. Institutional Operations, Chapter Taser Policies, Policy # 3.1.13 Less Lethal Implement, Electronic Control Device Policy, to authorize the use of Electronic Control Devices, or Tasers, by Corrections Officers employed by the Rosebud Sioux Tribe Adult Corrections Facility;

**BE IT FINALLY RESOYLED,** that the Rosebud Sioux Tribal Council authorizes and directs the President of the Rosebud Sioux Tribe or his authorized delegate to sign and execute the appropriate documents for modify the Rosebud Sioux Tribe Corrections, Public Law 93638 Contract, to include the attached Policy 3.1.13, Section 3. Institutional Operations, 3.1.13 Less Lethal Electronic Control Device Policy.

Institutional Operations, Chapter Taser Policies, Policy # 3.1.13 Less Lethal Implement, Electronic Control Device Policy, to authorize the use of Electronic Control Devices, or Tasers, by Corrections Officers employed by the Rosebud Sioux Tribe Adult Corrections Facility;

**BE IT FINALLY RESOYLED,** that the Rosebud Sioux Tribal Council authorizes and directs the President of the Rosebud Sioux Tribe or his authorized delegate to sign and execute the appropriate documents for modify the Rosebud Sioux Tribe Corrections, Public Law 93638 Contract, to include the attached Policy 3.1.13, Section 3. Institutional Operations, 3.1.13 Less Lethal Electronic Control Device Policy.
