- WHEREAS, The Rosebud Sioux Tribe is a federally recognized Indian Tribe organized pursuant to the Indian Reorganization Act of 1934 and all pertinent amendments thereof; and
- WHEREAS, the Rosebud Sioux Tribe is governed by a Tribal Council made up of elected representatives who act in accordance with the powers granted by its Constitution and By-laws; and
- WHEREAS, the Rosebud Sioux Tribal Council is authorized to promulgate and enforce ordinances for the maintenance of law and order, and to safeguard the peace and morals, and general welfare of the Tribe, pursuant to the Rosebud Sioux Tribe Constitution and By-laws, Article I, Sections 1 (k), and (m); and
- WHEREAS, the Rosebud Sioux Tribe has established the Tribal Budget and Finance Committee pursuant to the RST Ordinance No. 80-07, to operate with input from the directors of tribal programs and Tribal Council members to develop and coordinate all aspects of tribal budget activities in accordance with the Rosebud Sioux Tribe's Constitution and By-Laws; and
- WHEREAS, the Rosebud Sioux Tribe Health Administration Meth Rehab Program would like to contract with Generation Red Road, Inc. for curriculum development for the Meth Rehab Program. Their focus is on community input to develop culturally specific programming for tribal communities. Generation Red Road will integrate Rosebud Sioux Tribe's culture, life skills and lessons within the Red Road Approach curriculum that can guide them in their path moving forward; and
- WHEREAS, Generation Red Road will provide teachings to adults by integrating Rosebud Sioux Tribe culture, Creative Arts into workbooks. Generation Red Road will train agency staff on running weekly groups twice a month for the duration of Red Road series; and
- WHEREAS, Project Objectives will include increasing the client's capacity in learning about the importance of healthy lifestyle, increase their awareness of societal pressures and the changes that can be made, understanding the importance of their cultural history and identity, building healthy leadership skills, and learning how Important their voice is and how it can be impactful; and
- WHEREAS, the proposed contract for the Generation Red Road curriculum is quoted at \$15,685; and
- **THEREFORE BE IT RESOLVED,** the Rosebud Sioux Tribal Council approves a contract between the Health Administration Meth Rehab Program and Generation Red Road for the proposed contract of \$15,685.
