- **WHEREAS**, The Rosebud Sioux Tribe is a federally recognized Indian Tribe organized pursuant to the Indian Reorganization Act of 1934 and pertinent amendments thereof: and
- **WHEREAS**, The Rosebud Sioux Tribe is governed by a Tribal Council made up of elected representatives who act in accordance with the powers granted to it by its Constitution and By-laws; and
- WHEREAS, The Rosebud Sioux Tribal Council is authorized to promulgate and enforce ordinances for the maintenance of law and order, and to safeguard the peace and morals, and general welfare of the Tribe, pursuant to the Rosebud Sioux Tribe Constitution and By-Laws Article IV Sections 1 (k), and (m), and
- WHEREAS, The Constitution and By-laws of the Rosebud Sioux Tribe Article V, Meetings of Council, provides that special meetings of the Rosebud Sioux Tribal Council shall be called by a majority of the Council in writing or by the Tribal President in writing with at least three days' notice in either case; and
- WHEREAS, Rosebud Sioux Tribal Council Ordinance to Implement the By-laws of the Rosebud Sioux Tribe's Constitution Section 8 A, Meetings of the Tribal Council, states regular meetings shall be held once a month on days and at places designated by resolution of the Tribal Council; and
- WHEREAS, The Rosebud Sioux Tribal Council has its regularly scheduled for Rosebud Casino reports and other matters, on March 23, 2022, beginning at 10:00, but scheduling issues have resulted in the unavailability of the RST Tribal Council Chambers; and

THEREFORE BE IT RESOLVED, that the Rosebud Sioux Tribe hereby designates the Rosebud Sioux Tribe Water Resources Conference Room for the March Monthly Casino report and other matters, March 23, 2022, beginning at 10:00 am CST; and

BE IT FURTHER RESOLVED, that a majority of the Rosebud Sioux Tribal Council also resolves to waive the rule requiring three day notice in writing prior to the scheduling of a special meeting of the Rosebud Sioux Tribal Council, as provided in RST Ordinance No. 86-04, Ordinance to Implement the Constitution and By-laws of the Rosebud Sioux Tribal Council Section 8 B;
