Resolution No. 2022-170

WHEREAS, the Rosebud Sioux Tribe is a federally recognized Indian Tribe organized pursuant to the Indian Reorganization Act of 1934 and all pertinent amendments thereof; and

WHEREAS, the Rosebud Sioux Tribe is governed by a Tribal Council made up of elected representatives who act in accordance with the powers granted to it by its Constitution and By-Laws; and

WHEREAS, pursuant to 25 CFR 900.12, the Rosebud Sioux Tribe will submit the Annual Funding Agreement for the following PL 93-638 Indian Self-Determination Contracts and Grants for Fiscal Year 2023; and

WHEREAS, the PL 93-638, Indian Self-Determination Contracts are identified as the;

WHEREAS, the Fiscal Year 2022 funding is not finalized between the Bureau of Indian Affairs and the Rosebud Sioux Tribe; and

WHEREAS, the Rosebud Sioux Tribe will be operating with Fiscal Year 2022 carry over funding on a Continuing Resolution in Fiscal Year 2023 for all P.L. 93-638 Indian Self Determination Contracts until the Fiscal Year 2023 is finalized; and

THEREFORE BE IT RESOLVED, Sicangu Resource Development is submitting the FY 2023 Annual Funding Agreement budgets to the BIA on July 1, 2022 on behalf of the Rosebud Sioux Tribe; and

BE IT FURTHER RESOLVED, that the Rosebud Sioux Tribal Council hereby authorizes the Tribal President or the designated official to sign and execute all pertinent applications, contracts and documents thereof.
