BE IT FURTHER RESOLVED, that the PL 93-638 Health programs will be administered by the Health Administrator; and

BE IT FURTHER RESOLVED, that no equipment or furniture purchases in excess of \$5,000 be made without RST Budget & Finance Committee's approval.



**ROSEBUD SIOUX TRIBE
RESOLUTION NO. 2021-291**

WHEREAS, the Rosebud Sioux Tribe is a federally recognized Indian Tribe organized pursuant to the Indian Reorganization Act of 1934 and all pertinent amendments thereof; and

WHEREAS, the Rosebud Sioux Tribe is governed by a Tribal Council made up of elected representatives who act in accordance with the powers granted to it by its Constitution and By-Laws; and

WHEREAS, the Rosebud Sioux Tribal Council is authorized to promulgate and enforce ordinances for the maintenance of law and order, and to safeguard the peace and morals, and general welfare of the Tribe, pursuant to the Rosebud Sioux Tribe Constitution and By-Laws, Article IV Sections 1(k), and (m); and

WHEREAS, the Rosebud Sioux Tribe has been awarded one-time funding from the Bureau of Indian Affairs primarily for contracted positions for Appellate Court Judges and conflict attorneys, Civil Advocate, Assistant Public Defender, Court Services Officer, Truancy Officer, two Archive Clerks, a part-time Associate Judge and to purchase a printer/copier/scanner in three separate awards totaling \$396,577.00; and

WHEREAS, the RST Court is responsible for the implementation of the new grant awards for the Bureau of Indian Affairs one-time funding as part of its Tribal Court Services self-determination contract; and

THEREFORE BE IT RESOLVED, that the Rosebud Sioux Tribal Council authorizes and approves the acceptance of the Bureau of Indian Affairs one-time funding to be implemented by the RST Court and approves the attached budgets totaling \$396,577 to be implemented by the Rosebud Sioux Tribal Court; and

BE IT FURTHER RESOLVED, that the Tribal Council hereby authorizes the Tribal Chairman or official designee to sign all pertinent applications, contracts and documents thereof.
