

ROSEBUD SIOUX TRIBE
Resolution No. 2022-214

WHEREAS, the Rosebud Sioux Tribe is a federally recognized Indian Tribe organized pursuant to the Indian Reorganization Act of 1934 and all pertinent amendments thereof; and

WHEREAS, the Rosebud Sioux Tribe is governed by a Tribal Council made up of elected representatives who act in accordance with the powers granted to it by its Constitution and By-laws; and

WHEREAS, the Rosebud Sioux Tribal Council is authorized to promulgate and enforce ordinances for the maintenance of law and order, and to safeguard the peace and morals, and general welfare of the Tribe, pursuant to the Rosebud Sioux Tribe Constitution and By-Laws Article IV Sections 1 (k), and (m), and

WHEREAS, the Rosebud Sioux Tribe submitted a request for funding consideration for the Tribe's Boarding School Program in the amount of \$150,000.00 utilizing FY 2021 carryover funding from the Great Plains Region; and

WHEREAS, the United States Department of Interior, Bureau of Indian Affairs, Great Plains Region, has approved the request in full and has notified the Tribe the amount of \$150,000.00 will be awarded through a one-time P.L. 93-638 grant, and has requested the Tribe to submit a tribal resolution, scope of work, budget and budget justification; and


NOW, THEREFORE BE IT RESOLVED, that the Rosebud Sioux Tribal Council approves and accepts the one-time P.L. 93-638 grant in the amount of \$150,000.00 for the Tribe's Boarding School Program, and approves and submits the attached scope of work, budget and budget justification; and


BE IT FURTHER RESOLVED, that the President of the Rosebud Sioux Tribe or his authorized delegate is authorized and directed to sign any and all related documents to support the Tribe's approval and acceptance of a one-time P.L. 93-638 funds for the Tribe's Boarding School Program.

CERTIFICATION

Other Program Expenses: This line item is created to pay for services or products not included in the line items listed above. Examples may be as follows; to purchase a large billboard for educational purposes related to truth, healing, and reconciliation as a result of the traumas brought on by boarding schools. Also, trees will be purchased and planted at the Boarding School Memorial Site to represent the children returned (and potentially more) to the Rosebud Sioux Tribe. Also included are any potential purchases of items necessary for the repatriation efforts not mentioned in the line items above.

Scope of Work

\$150,000 reimbursement funds were given to the tribe for the purposes of identifying and to repatriate any Sicangu children enrolled in boarding schools who have not returned home. The tribe has made the decision to give the responsibility to the Sicangu Youth Council/Tokala Inajinyo Mentors under the administration of the Executive Director to manage these funds as they are currently doing their boarding school research, planning of future projects associated with repatriation while continuing to participate in vital youth leadership trainings.

These funds will provide much needed items, products and access to necessary travel opportunities for the purpose of meeting the goals of this project.

- Goal 1:** Research historical documents, identify, locate & bring our relatives home from boarding schools.
- Goal 2:** To ensure that these funds will provide the necessary repatriation activities which includes many travel responsibilities of the SYC/TM and other tribal officials involved in the repatriation efforts.
- Goal 3:** Establish a *"Truth, Healing, and Reconciliation Center"* for the purpose of archiving vital information on all boarding schools for better access for the public; specifically the tribal members.
- Goal 4:** Establish the *"Tokeya Gli Win" Youth Resource Center*. (First To Come Home Woman)
- Goal 5:** To establish a memorial for all relatives who have not returned home since 1879 by creating the *Boarding School Memorial Site* to honor those who have returned home and especially for those finally returning home.

Budget Justification

Supplies: This line item will provide supplies for cultural activities or ceremonies involving repatriation and the projects listed above; office supplies for manual development for all of the boarding school in state of South Dakota, and supplies needed for repatriation research activities.-

Equipment: This line item will provide a Camera, SD cards, video cameras to document activities for educational and research purposes related to truth, healing, and reconciliation as a result of the traumas brought on by boarding schools. This line item will provide a PA System (to include speakers) will be used for gatherings and activities regarding dissemination of research and 2 Apple Desktops to be used for educational purposes and research.

Travel: This line item will pay for mileage, lodging, and per diem for Sicangu Youth Council/Tokala Mentors and other tribal officials to attend future repatriation efforts and in addition, for the SYC; capacity-building event, such as conferences, meetings, trainings, workshop, and other events, in addition to guest speaking invitations.

Contractual: This line item will pay for consultants to provide various services to the youth, such as capacity-building (training, education, experiential learning), cultural support and services, dietary services, and other needs specific to research activities. Other contractual services include participation at gatherings for tribal members.

Dietary: This line item will help pay for food for public or youth gatherings; and cultural food ingredients for cultural/spiritual activities.
