

**ROSEBUD SIOUX TRIBE
RESOLUTION NO. 2022-133**

- WHEREAS,** the Rosebud Sioux Tribe is a federally recognized Indian Tribe organized pursuant to the Indian Reorganization Act of 1934 and all pertinent amendments thereof; and
- WHEREAS,** the Rosebud Sioux Tribe is governed by the Tribal Council comprised of elected representatives who act in accordance with the powers delegated to it and by the Constitution and Bylaws of the Tribe; and
- WHEREAS,** the Rosebud Sioux Tribe Council is authorized to promulgate and enforce ordinances for the maintenance of law and order, and to safeguard the peace and morals, and general welfare of the Tribe, pursuant to the Rosebud Sioux Tribe Constitution and By-Laws, Article V Sections 1(k), and (m); and
- WHEREAS,** the Rosebud Sioux Tribe Constitution and By-Laws Preamble states it is “to promote the welfare of the present generation and our posterity, in education and industry”; and
- WHEREAS,** The United Nations Declaration of Indigenous Peoples, Article 4 states, “Indigenous peoples, in exercising their right to self-determination, have the right to autonomy or self-government in matters relating to their internal and local affairs, as well as ways and means for financing their autonomous functions”; and
- WHEREAS,** The United Nations Declaration of the Rights of Indigenous Peoples, Article 14, Section 1, recognizes Lakota tribes, Lakota communities, and Lakota parents possess the inherent right to establish and control their educational systems and institutions and provide curriculum(s) in their own languages, in a manner appropriate to their cultural methods of teaching and learning that will best meet the needs of their children; and
- WHEREAS,** The United Nations Declaration of the Rights of Indigenous Peoples, Article 15, Section 1, recognizes Indigenous peoples have the right to the dignity and diversity of their cultures, traditions, histories, and aspirations which shall be appropriately reflected in education and public information; and
- WHEREAS,** the Rosebud Sioux Tribe Education Committee approved the Tribal Education Consultation Policy titled *Tribal and Community Involvement in Decision Making* in April 2018; and
- WHEREAS,** this policy was enacted to meet the requirements of the Every Student Succeeds Act (ESSA), Federal Impact Aid Law, and the Rosebud Sioux Tribe Education Code; and
- WHEREAS,** All Educational Institutions/ Local Education Agencies (LEAs) on Rosebud Sioux Tribe land are required to comply with the policy; and
- WHEREAS,** ESSA requires consultation with Tribal Governments for these programs:


WHEREAS, the Rosebud Sioux Tribe is a sovereign nation and inherent sovereignty means this sovereignty is not given, nor taken, Now


