

**ROSEBUD SIOUX TRIBE
RESOLUTION NO. 2022-163**

Supporting the Nomination of Jordan Rahn to the HUD Tribal Advisory Committee (TIAC)

WHEREAS, the Rosebud Sioux Tribe is a federally recognized Indian Tribe organized pursuant to the Indian Reorganization Act of 1934 and all pertinent amendments thereof; and

WHEREAS, the Rosebud Sioux Tribe is governed by a Tribal Council made up of elected representative who act in accordance with the powers granted to it by its Constitution and By-Laws; and

WHEREAS, Article IV, Section 1(a) of the Rosebud Sioux Tribe Constitution and By-Laws empowers the Tribal Council with the authority to negotiate with Federal, State, and Local Governments on behalf of the Tribe; and

WHEREAS, the U.S. Department of Housing and Urban Development has, on March 31, 2022, published a "Notice of Intent to Establish a Tribal Intergovernmental Advisory Committee; Structure and Request for Nominations" in the Federal Register, Vol 87, No. 62, page 18807 (the "HUD Notice"); and

WHEREAS, the HUD Notice requests nominations from "only elected officers of a tribal government acting in their official capacities with authority to act on behalf of the tribal government"; and

WHEREAS, providing low-income and affordable housing opportunities and assistance to its members is a priority for the Rosebud Sioux Tribe; and

WHEREAS, Council Member Jordan Rahn has involvement and experience with housing issues on the Rosebud Sioux Tribe Reservation; now

THEREFORE BE IT RESOLVED, that the Tribe nominates Council Member Jordan Rahn to be appointed to the HUD Tribal Advisory Committee and to participate in the Committee for a term of three years.


C E R T I F I C A T I O N

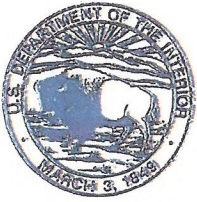
